COUNT 1:

And the Grand Jurors aforesaid, upon their oath aforesaid, do further present and say that between the 1st day of March 2022 and the 4<sup>th</sup> day of May 2022, and in the State and County aforesaid, JOHN NOLAN KEATHLEY knowingly or intentionally engaged in masturbation by self-stimulation inside of the classroom he had been assigned on the property of Greenbrier Middle School, a public school and JOHN NOLAN KEATHLEY should have reasonably known that a child or children would be present on the property at the time of the offense, in violation of TCA 39-13-517 and against the peace and dignity of the State of Tennessee.

COUNT 2:

And the Grand Jurors aforesaid, upon their oath aforesaid, do further present and say that between the 1st day of March 2022 and the 4<sup>th</sup> day of May 2022, and in the State and County aforesaid, JOHN NOLAN KEATHLEY knowingly or intentionally engaged in masturbation by self-stimulation inside of one of the boys bathrooms on the property of Greenbrier Middle School, a public school and JOHN NOLAN KEATHLEY should have reasonably known that a child or children would be present on the property at the time of the offense, in violation of TCA 39-13-517 and against the peace and dignity of the State of Tennessee.

COUNT 3:

And the Grand Jurors aforesaid, upon their oath aforesaid, do further present and say that between the 1st day of March 2022 and the 4<sup>th</sup> day of May 2022, and in the State and County aforesaid, JOHN NOLAN KEATHLEY engaged in sexual behavior for the purpose of having a minor child, view such activity, in violation of TCA 39-13-529 and against the peace and dignity of the State of Tennessee.

**COUNT 4:**

And the Grand Jurors aforesaid, upon their oath aforesaid, do further present and say that between the 1st day of March 2022 and the 4<sup>th</sup> day of May 2022, and in the State and County aforesaid, JOHN NOLAN KEATHLEY engaged in sexual behavior for the purpose of having a minor child, view such activity, in violation of TCA 39-13-529 and against the peace and dignity of the State of Tennessee.

**COUNT 5:**

That between the 1st day of March 2022 and the 4<sup>th</sup> day of May 2022, and in the State and county aforesaid, JOHN NOLAN KEATHLEY intentionally exposed his penis and engaged in sexual contact by engaging in masturbation while inside Greenbrier Middle School during hours when students were present and JOHN NOLAN KEATHLEY should have reasonably expected the acts would be viewed by another for the sexual gratification of JOHN NOLAN KEATHLEY, in violation of TCA 39-13-511 and against the peace and dignity of the State of Tennessee.
